Introduction and Purpose

These Official Rules ("Rules") of the Super League Gaming ("SLG") League of Legends City Rec video game events ("City Rec") apply to each player who enters to play in City Rec. These Rules apply only to official City Rec play and not to other competitions, tournaments or organized play of League of Legends ("LoL" or the "game").

Super League Gaming, a Delaware limited liability company, has established these Rules for the social play of LoL in order to ensure the integrity of the system established by the City Rec for play of LoL and create a fun, safe environment for the players.

1. Eligibility

1.1. Equipment

Players must have access to, bring and use a laptop that meets SLG minimum specifications.

1.2. Riot Disciplinary Status

Players may not have any current disciplinary suspension from Riot affiliated competitions. Suspensions from the LCS or foreign leagues will be upheld by City Rec.

1.3. Eligible LoL Account

Players must have a League of Legends account in good standing with Riot games.

2. Prizes

2.1. No Promise of Prizes

There is no official prize structure for City Rec. From time to time SLG may, at its sole discretion, offer prizes on an event-by-event basis and a theater-by-theater basis. SLG makes no promise of prizes at any event. In the event that SLG does offer prizes at any particular event, the rules governing such prizes shall be published before the event via SLG social media channels.

3. Lateness, Absence and Summoner Name Restrictions

3.1. Lateness and Absence

Player acknowledges that it is critical for City Rec to run according to time schedule. Players may arrive to a City Rec event at any time but City Rec events will end at their scheduled end-time regardless of when a player arrives.

3.2. No Refunds

No refund of entry fee shall be provided for any reason.

3.3. Transferability

If a player purchases a City Rec ticket and subsequently cannot attend the event, that ticket may be transferred to another person. Each ticket is good for one entry into the specific event for which the ticket was purchased.

3.4. Summoner Name Restrictions

Summoner Names may not contain: vulgarities or obscenities; LoL champion derivatives or other similar character names; or derivatives of products or services that may create confusion.

4. Action Squad Hosts

4.1. Role of Action Squad

Action Squad are City Rec officials who are responsible for ensuring a safe and enjoyable environment for all City Rec players in any particular theater.

4.1.1. Action Squad Responsibilities

Action Squad oversight may include, but is not limited to the following:

4.1.1.1. Verifying Ticket Purchases

Verifying players have purchased a ticket for the event

4.1.1.2. Technical Issue Support

Supporting the solution of any technical issues

4.1.1.3. Issuing Penalties

Issuing penalties in response to any Rule violations before, during, or after a City Rec event.

4.1.2. Finality of Judgment

All judgments and decisions by Action Squad are final.

5. Player Conduct

5.1. Player Conduct

5.1.1. Fair and Enjoyable Play

Players shall not engage in any activity or behavior which might reasonably bring detriment to another Player's City Rec experience, including but not limited to hacking, exploiting, ringing, cheating, and intentional disconnection.

5.1.1.1. City Rec Discretion

Any other further act, failure to act, or behavior which, in the sole judgment of City Rec officials, violates these Rules and/or the standards of integrity established by City Rec.

5.1.2. Profanity and Hate Speech

A Player may not use language that is obscene, foul, vulgar, insulting, threatening, abusive, libelous, slanderous, defamatory or otherwise offensive or objectionable; or promote or incite hatred or discriminatory conduct, in or near the match area, at any time. A Player may not use any facilities, services or equipment provided or made available by City Rec or its contractors to post, transmit, disseminate or otherwise make available any such prohibited communications. A Player may not use this type of language on social media or during any public facing events such as streaming.

5.1.3. Disruptive Behavior / Insults

A Player may not take any action or perform any gesture directed at an opposing Player, fan, or official, or incite any other individual(s) to do the same, which is insulting, mocking, disruptive or antagonistic.

5.1.4. Abusive Behavior

Abuse of City Rec officials, opposing Players, or audience members will not be tolerated. Repeated etiquette violations, including but not limited to touching another player's computer, body or property will result in penalties. Players and their guests (if any) must treat all individuals attending a match with respect.

5.1.5. No In-Client Spectators

Only City Rec players are allowed in the game lobby. No additional in-client spectators are permitted for any reason. Spectators may attend City Rec events and spectate in-person.

5.1.6. No Streaming

Players are not permitted to stream their tournament matches publicly or privately on any platform or service. Players may stream personal or professional recordings of the match after the broadcast has officially completed once they are no longer using arena bandwidth.

5.11. Arena Bandwidth

Arena bandwidth is for City Rec usage only. Players shall not use arena bandwidth for any other usage, including but not limited to playing non-City Rec games of League of Legends, accessing and/or viewing any non-City Rec website or video, downloading any information, data, or files not directly relating to being able to play City Rec.

5.2 Unsportsmanlike Behavior

5.2.1. Responsibility Under Code

Unless expressly stated otherwise, offenses and infringements of these Rules are punishable, whether or not they were committed intentionally. Attempts to commit such offenses or infringements are also punishable.

5.2.2. Harassment

Harassment is forbidden. Harassment is defined as systematic, hostile, and repeated acts taking place over a considerable period of time, or a singular egregious instance, which is/are intended to isolate or ostracize a person and/or affect the dignity of the person.

5.2.3 Sexual Harassment

Sexual harassment is forbidden. Sexual harassment is defined as unwelcome sexual advances. The assessment is based on whether a reasonable person would regard the conduct as undesirable or offensive. There is zero tolerance for any sexual threats/coercion or the promise of advantages in exchange for sexual favors.

5.2.4 Discrimination and Denigration

Players may not offend the dignity or integrity of a country, private person, or group of people through contemptuous, discriminatory, or denigrating words or actions on account of race, skin color, ethnic, national or social origin, gender,

language, religion, political opinion or any other opinion, financial status, birth or any other status, sexual orientation or any other reason.

5.2.5 Statements Regarding City Rec, Riot Games, and League of Legends

Players may not give, make, issue, authorize, or endorse any statement or action having, or designed to have, an effect prejudicial or detrimental to the best interest of City Rec, Riot Games or its affiliates, or League of Legends, as determined in the sole and absolute discretion of City Rec.

5.2.6 Player Behavior Investigation

If City Rec or Riot determines that a Player has violated the Summoner's Code, the LoL Terms of Service, or other rules of LoL, City Rec officials may assign penalties at their sole discretion. If a City Rec official contacts a Player to discuss the investigation, the Player is obligated to tell the truth. If a Player lies to a City Rec official creating obstruction of the investigation then the Player is subject to punishment.

5.2.7 Criminal Activity

A Player may not engage in any activity which is prohibited by common law, statute, or treaty and which leads to or may be reasonably deemed likely to lead to conviction in any court of competent jurisdiction.

5.2.8 Moral Turpitude

A Player may not engage in any activity which is deemed by the City Rec to be immoral, disgraceful, or contrary to conventional standards of proper ethical behavior.

5.2.9 Confidentiality

A Player may not disclose any confidential information provided by City Rec or any affiliate of Riot Games, by any method of communication, including all social media channels.

5.2.10 Bribery

No Player may offer any gift or reward to a player, City Rec official, Riot Games employee, or person connected with or employed by another City Rec team for services promised, rendered, or to be rendered in defeating or attempting to defeat a competing team.

5.2.11 Gifts

No Player may accept any gift, reward or compensation for services promised, rendered, or to be rendered in connection with competitive play of the game, including services related to defeating or attempting to defeat a competing team or services designed to throw or fix a match or game.

5.2.12 Non Compliance

No Player may refuse or fail to apply the instructions or decisions of City Rec officials.

5.2.13 Match-Fixing

No Player may offer, agree, conspire, or attempt to influence the outcome of a game or match by any means that are prohibited by law or these Rules.

5.2.14 Document or Miscellaneous Requests

Documentation or other reasonable items may be required at various times throughout the City Rec as requested by City Rec officials. Penalties may be imposed if the documentation or items requested are not received and/or completed at the required time or do not meet the standards set by the City Rec.

5.3. Association with Gambling

No Player or City Rec official may take part, either directly or indirectly, in betting or gambling on any results of any League of Legends tournament or match globally.

5.4. Subjection to Penalty

Any person found to have engaged in or attempted to engage in any act that City Rec believes, in its sole and absolute discretion, constitutes unfair play, will be subject to penalty. The nature and extent of the penalties imposed due to such acts shall be in the sole and absolute discretion of the City Rec.

5.5. Penalties

Upon discovery of any Player committing any violations of the rules listed above, the City Rec may, without limitation of its authority under Section 8, issue the following penalties:

- 5.5.1. Verbal Warning
- 5.5.2. Suspension
- 5.5.3. Disqualification

5.6 Penalty Schedule

Repeated infractions are subject to escalating penalties, up to, and including, disqualification from future participation in City Rec. It should be noted that penalties may not always be imposed in a successive manner. City Rec, in its sole discretion, for example, can disqualify a player for a first offense if the action of said player is deemed egregious enough to be worthy of disqualification by City Rec.

6. Spirit of the Rules

6.1. Finality of Decisions

All decisions regarding the interpretation of these rules, player eligibility, scheduling and staging of the City Rec, and penalties for misconduct, lie solely with City Rec, the decisions of which are final. City Rec decisions with respect to these Rules cannot be appealed and shall not give rise to any claim for monetary damages or any other legal or equitable remedy.

6.2. Rule Changes

These Rules may be amended, modified or supplemented by City Rec, from time to time, in order to ensure fair play and the integrity of City Rec.

6.3. Best Interests of the City Rec

City Rec officials at all times may act with the necessary authority to preserve the best interests of the City Rec. This power is not constrained by lack of specific language in this document. City Rec officials may use any form of punitive actions at their disposal against any entity whose conduct is not within the confines of the best interests of the City Rec.
